I-95 North to Exit 4. At end of ramp turn left, Indian Field Road. Continue to traffic light, left on Putnam Ave (US 1). At 4th light, turn right onto Maple Ave. Enter first driveway on right.

Merritt Parkway Northbound from NY:

Exit 31, left on North Street. Proceed 2 miles to end of North Street, bear left onto Maple Ave. Office is last driveway on the left, across from Church.

From Connecticut via I-95: I-95 South toward New York City, Take Exit 21 toward White Plains/ Tappan Zee Bridge, Merge onto I-287 West, Take Exit 10 for Bowman Ave/Webb Ave, Merge onto Webb Ave, Turn right onto Westchester Ave, East, at traffic light make left turn into Purchase Professional Park, Proceed to Building 3010, Suite 306.

From Connecticut via Merritt Parkway: Merritt Parkway South toward New York City, Merritt Parkway becomes the Hutchinson River Parkway, Continue on Hutchinson River Parkway South, Take Exit 28 Lincoln Ave toward Rye Brook/Harrison, Turn left at end of exit ramp onto Lincoln Ave, at traffic light turn right into Purchase Professional Park, proceed to Building 3010, Suite 306.

From White Plains:
